LINEARISATIONS OF TRIANGULATED CATEGORIES WITH RESPECT TO FINITE GROUP ACTIONS

ABSTRACT. Given an action of a finite group on a triangulated category, we investigate under which conditions one can construct a linearized triangulated category using DG-enhancements. In particular, if the group is a finite group of automorphisms of a smooth projective variety and the category is the bounded derived category of coherent sheaves, then our construction produces the bounded derived category of coherent sheaves on the smooth quotient variety or stack. We also consider the action given by the tensor product with a torsion canonical bundle and the action of a finite group on the category generated by a spherical object.

1. Introduction

It is well-known that triangulated categories, which are ubiquitous in several areas of mathematics, are not rigid enough to perform certain operations: for example, the category of exact functors between triangulated categories is not itself triangulated. Similarly, given a finite group G acting on a triangulated category \mathcal{T} , there is no straightforward definition of an equivariant triangulated category. The purpose of this note is to present a possible solution to this problem using differential graded (DG) categories.

One possible motivation for this comes from geometry. The bounded derived category $D^b(X)$ of a smooth projective variety X has drawn a lot of attention in recent years since it encodes a lot of interesting geometric information which is not visible when working with the abelian category of sheaves. The group of autoequivalences $Aut(D^b(X))$ is also a very interesting object to study. It is completely understood for varieties with ample canonical (or anticanonical) bundle, but its structure is unknown in general. Of course, similar questions can be asked about any triangulated category.

If the triangulated category happens to be $D^b(X)$ and the group G is contained in Aut(X) and is finite, then a reasonable construction should produce $D^b([X/G])$, where [X/G] is the smooth quotient variety or the quotient stack (if the action is not free). On the other hand, if G is not some group of automorphisms one might hope to extract some interesting geometry out of its action on $D^b(X)$. Unfortunately, we do not have many examples of finite groups acting on $D^b(X)$ at the moment, but since there are various sources for triangulated categories it is reasonable to hope that the techniques developed in this note will also be applicable in other situations.

The basic idea of the construction is to use linearizations. This is well-established for sheaves (or modules): If $G \subset \operatorname{Aut}(X)$ is finite, then the abelian category $\operatorname{\mathbf{Coh}}^G(X)$

of linearized sheaves on X is equivalent to $\operatorname{Coh}([X/G])$. We would like to have something similar for triangulated categories. However, there are two basic problems. The first is that a reasonable notion of a group acting on a category has to assign an autoequivalence to any group element (and the assignment is subject to some conditions), but the group $\operatorname{Aut}(\mathcal{T})$ is the set of autoequivalences modulo isomorphisms. Furthermore, it is fairly easy to see that the category of linearized objects (with respect to a reasonable group action) of \mathcal{T} is not necessarily triangulated, because cones are not functorial (a problem alluded to in the first paragraph).

The remedy is to consider triangulated categories that are homotopy categories of pretriangulated DG-categories and autoequivalences, which come from equivalences on the DG-level. Our main result can be roughly summarized as follows, see Proposition 4.3 and Corollary 5.3 (and Definition 3.9 for our notion of the linearized category).

Theorem 1.1. Let G be a finite group acting on a triangulated category $\mathcal{T} \simeq H^0(\mathcal{A})$ which is the homotopy category of a pretriangulated DG-category \mathcal{A} and such that the action of G comes from an action on \mathcal{A} . Then a linearized triangulated category $\mathcal{T}^G_{\mathcal{A}}$ can be constructed. If $\mathcal{T} \simeq D^b(X)$ and G is a finite group of automorphisms of X, then $D^b(X)^G \simeq D^b([X/G])$. Given a variety S with a canonical bundle ω_S which is torsion of order n, the triangulated category linearized with respect to the action of $\mathbb{Z}/n\mathbb{Z}$, where one identifies 1 with the autoequivalence given by the tensor product with ω_S , is equivalent to the bounded derived category of the canonical cover.

It is in general not clear whether the above result depends on the choice of the category \mathcal{A} (so the above statements have to be read as involving specific choices of \mathcal{A}), but see Proposition 3.12 for a partial result. In any case, using a fairly natural \mathcal{A} we can prove the following. For example, given a Fourier–Mukai partner Y of X and a group G acting on Y, the linearized category $\mathrm{D}^b(X)^G$ with respect to the action of G induced by the Fourier–Mukai equivalence is equivalent to $\mathrm{D}^b([Y/G])$, see Corollary 4.4.

Lastly, the category generated by a spherical object admits actions of finite groups and we prove that the spherical object becomes an exceptional one in the linearized category; see Proposition 5.6.

Remark 1.2. We can proceed in a similar fashion if the group is an infinite discrete group, but have to adjust certain things: For example, we then have to work with (the derived category of) quasi-coherent sheaves, but the approach still works.

The note is organized as follows. In Section 2, we recall some basic facts about DG-categories, define the linearized triangulated category in the following section, consider the above-mentioned geometric situation in Section 4 and look at new examples in the last section.

Conventions. From Section 3 on we work over the field of complex numbers (although most of the results hold over an arbitrary field provided the order of the group is prime to the characteristic). All functors between derived categories are assumed to be exact. Unless stated otherwise all considered groups are finite.

2. Differential graded categories

In this section, we recall the necessary notions and facts from the theory of differential graded categories. For details see, e.g., [6, 9, 12].

Definition 2.1. A differential graded category or DG-category over a field K is a K-linear additive category \mathcal{A} such that for any two objects $X, Y \in \mathcal{A}$ the space of morphisms Hom(X,Y) is a complex, the composition of morphisms

$$\operatorname{Hom}(X,Y) \otimes \operatorname{Hom}(Y,Z) \longrightarrow \operatorname{Hom}(X,Z)$$

is a chain map and the identity with respect to the composition is closed of degree 0.

Example 2.2. The most basic example of a K-linear DG-category is the category of complexes of K-vector spaces. For two complexes X and Y we define $\operatorname{Hom}(X,Y)^n$ to be the K-vector space formed by families $\alpha = (\alpha^p)$ of morphisms $\alpha^p : X^p \longrightarrow Y^{p+n}$, $p \in \mathbb{Z}$. We define $\operatorname{Hom}_{\operatorname{DG}}(X,Y)$ to be the graded K-vector space with components $\operatorname{Hom}(X,Y)^n$ and whose differential is given by

$$d(\alpha) = d_Y \circ \alpha - (-1)^n \alpha \circ d_X.$$

The DG-category $C_{\mathrm{DG}}(K)$ has as objects complexes and the morphisms are defined by

$$C_{\mathrm{DG}}(K)(X,Y) = \mathrm{Hom}_{\mathrm{DG}}(X,Y).$$

Of course, starting with the category of complexes over an arbitrary K-linear abelian (or additive) category one can associate a DG-category to it in a similar manner.

Clearly, we get back the usual category of complexes by taking as morphisms only the closed morphisms of degree zero and we get the usual homotopy category if we replace $\operatorname{Hom}_{\mathrm{DG}}(X,Y)$ by $\ker(d^0)/\operatorname{im}(d^{-1})$.

A DG-functor $\Phi \colon \mathcal{A} \longrightarrow \mathcal{B}$ between DG-categories \mathcal{A} and \mathcal{B} is by definition required to be compatible with the structure of complexes on the spaces of morphisms. If $\Phi, \Psi \colon \mathcal{A} \longrightarrow \mathcal{B}$ are two DG-functors, then we define the complex of graded morphisms $\operatorname{Hom}(\Phi, \Psi)$ to be the complex whose nth component is the space formed by families of morphisms $\phi_X \in \operatorname{Hom}_{\mathcal{B}}(\Phi(X), \Psi(X))^n$ such that $(\Psi\alpha)(\phi_X) = (\phi_Y)(\Phi\alpha)$ for all $\alpha \in \operatorname{Hom}_{\mathcal{A}}(X,Y)$, where $X,Y \in \mathcal{A}$. The differential is given by that of $\operatorname{Hom}_{\mathcal{B}}(\Phi(X), \Psi(X))$. Using this we define the DG-category of DG-functors from \mathcal{A} to \mathcal{B} , denoted by $\operatorname{Hom}(\mathcal{A}, \mathcal{B})$, to be the category with DG-functors as objects and the above described spaces as morphisms. Note that the DG-functors between \mathcal{A} and \mathcal{B} are precisely the closed morphisms of degree zero in $\operatorname{Hom}(\mathcal{A}, \mathcal{B})$.

To any DG-category \mathcal{A} one can naturally associate two other categories: Firstly, there is the graded category $Ho^{\bullet}(\mathcal{A}) = H^{\bullet}(\mathcal{A})$ having the same objects as \mathcal{A} and where the space of morphisms between two objects X, Y is by definition the direct sum of the cohomologies of the complex $Hom_{\mathcal{A}}(X,Y)$. Secondly, restricting to the cohomology in degree zero we get the homotopy category $Ho(\mathcal{A}) = H^{0}(\mathcal{A})$.

Definition 2.3. A DG-functor $\Phi: \mathcal{A} \longrightarrow \mathcal{B}$ is *quasi fully faithful* if for any two objects X, Y in \mathcal{A} the map

$$\operatorname{Hom}(X,Y) \longrightarrow \operatorname{Hom}(\Phi(X),\Phi(Y))$$

is a quasi-isomorphism and Φ is a quasi-equivalence if in addition the induced functor $H^0(\Phi)$ is essentially surjective. Two DG-categories \mathcal{A} and \mathcal{B} are called quasi-equivalent if there exist DG-categories $\mathcal{C}_1, \ldots, \mathcal{C}_n$ and a chain of quasi-equivalences $\mathcal{A} \longleftarrow \mathcal{C}_1 \longrightarrow \cdots \longleftarrow \mathcal{C}_n \longrightarrow \mathcal{B}$.

A DG-functor $\Phi: \mathcal{A} \longrightarrow \mathcal{B}$ is a DG-equivalence if it is fully faithful and for every object $B \in \mathcal{B}$ there is a closed isomorphism of degree 0 between B and an object of $\Phi(\mathcal{A})$.

We also have to recall the following construction from [3].

Definition 2.4. Let \mathcal{A} be a DG-category. Define the pretriangulated hull $\mathcal{A}^{\text{pretr}}$ of \mathcal{A} to be the following category. Its objects are formal expressions $(\bigoplus_{i=1}^n C_i[r_i], q)$, where $C_i \in \mathcal{A}$, $r_i \in \mathbb{Z}$, $n \geq 0$, $q = (q_{ij})$, $q_{ij} \in \text{Hom}(C_j, C_i)[r_i - r_j]$ is homogeneous of degree 1, $q_{ij} = 0$ for $i \geq j$, $dq + q^2 = 0$. If $C = (\bigoplus_{j=1}^n C_j[r_j], q)$ and $C' = (\bigoplus_{i=1}^m C_i'[r_i'], q')$ are objects in $\mathcal{A}^{\text{pretr}}$, then the \mathbb{Z} -graded K-module Hom(C, C') is the space of matrices $f = (f_{ij})$, $f_{ij} \in \text{Hom}(C_j, C_i')[r_i' - r_j]$ and the composition map is matrix multiplication. The differential $d: \text{Hom}(C, C') \longrightarrow \text{Hom}(C, C')$ is defined by $d(f) = (df_{ij}) + q'f - (-1)^l fq$ if $\deg f_{ij} = l$. The category \mathcal{A} is called pretriangulated if the natural fully faithful functor $\Psi: \mathcal{A} \longrightarrow \mathcal{A}^{\text{pretr}}$ is a quasi-equivalence and \mathcal{A} is strongly pretriangulated if Ψ is a DG-equivalence.

The reason for introducing the pretriangulated hull is that its homotopy category is always triangulated, see [3] or [4, Section 4.3]. Thus, we have the following

Definition 2.5. Let \mathcal{A} be a DG-category. The associated triangulated category is $\mathcal{A}^{tr} := H^0(\mathcal{A}^{pretr})$.

Definition 2.6. Let \mathcal{T} be a triangulated category. An *enhancement* of \mathcal{T} is a pair (\mathcal{A}, ϵ) , where \mathcal{A} is a pretriangulated DG-category and $\epsilon \colon H^0(\mathcal{A}) \xrightarrow{\sim} \mathcal{T}$ is an equivalence of triangulated categories.

The category \mathcal{T} is said to have a unique enhancement if it has one and for two enhancements (\mathcal{A}, ϵ) and $(\mathcal{A}', \epsilon')$ there exists a quasi-functor (see [12]) $\phi \colon \mathcal{A} \longrightarrow \mathcal{A}'$ which induces an equivalence $H^0(\phi) \colon H^0(\mathcal{A}) \longrightarrow H^0(\mathcal{A}')$. One then calls the two enhancements equivalent. Two enhancements are called *strongly equivalent* if there exists a quasi-functor ϕ such that $\epsilon' \circ H^0(\phi)$ and ϵ are isomorphic.

If $\mathcal{T} \simeq \mathrm{D}^b(X)$ for X a smooth projective variety (or a smooth stack), the enhancement one usually works with is

(2.1)
$$\mathcal{A} := \mathcal{D}_{\mathrm{DG}}^b(X) := C_{\mathrm{DG}}(I(X)),$$

where $C_{DG}(I(X))$ is the DG-category of bounded-below complexes of injective sheaves with bounded coherent cohomology.

Denote the two projections from $X \times X$ to X by q and p. Let $F \colon D^b(X) \longrightarrow D^b(X)$ be an equivalence. By results of Orlov [13,14] we know that F is of Fourier–Mukai type, that is, there exists a unique (up to isomorphism) object $\mathcal{P} \in D^b(X \times X)$, called the kernel, such that $F \simeq \Phi_{\mathcal{P}}$, where $\Phi_{\mathcal{P}}(E) = p_*(q^*E \otimes \mathcal{P})$ for any $E \in D^b(X)$. It is clear that any equivalence of FM-type lifts to a DG-endofunctor of $D^b_{\mathrm{DG}}(X)$. In fact, the DG-lifts of the three standard autoequivalences (shifts, automorphisms and line bundle twists) do lift to DG-equivalences of the above described enhancement, but for a general autoequivalence this is not clear. Given an arbitrary triangulated category the existence and/or uniqueness of an enhancement is not known (but see [12] for several results) and the question whether an exact functor lifts to the DG-enhancement is also open.

3. Linearisations

Let G be a group and \mathcal{C} be any category. The following notions are based on Deligne's article [5]. A weak action of G on \mathcal{C} is the assignment of an autoequivalence g^* to any element $g \in G$ such that there exist isomorphisms of functors $c_{g,h}: (gh)^* \simeq h^*g^*$ for all $g, h \in G$. Note that this, in particular, implies that $1^* \simeq \mathrm{id}_{\mathcal{C}}$. An action of G on \mathcal{C} is a weak action such that the isomorphisms $c_{g,h}$ satisfy an associativity condition:

$$(ghi)^* \longrightarrow i^*(gh)^*$$

$$\downarrow \qquad \qquad \downarrow$$

$$(hi)^*q^* \longrightarrow i^*h^*q^*.$$

Of course, there is a "covariant" version of the above definition.

Definition 3.1. A linearization of an object A of a category \mathcal{A} consists of a collection of morphisms $\lambda_g \colon A \longrightarrow g^*(A)$ in \mathcal{A} for each $g \in G$ which satisfy the following: $\lambda_1 = \operatorname{id}$ and $\lambda_{gh} = h^*(\lambda_g)\lambda_h$, that is

$$A \xrightarrow{\lambda_h} h^*(A) \xrightarrow{h^*(\lambda_g)} h^*(g^*(A)).$$

A pair (A, λ_g) will be called a *linearized object*. We define a morphism between two linearized objects (A, λ_g) and (A', λ'_g) to be a G-invariant morphism, that is, a morphism $\varphi \colon A \longrightarrow A'$ in A such that the following diagram commutes in A for all $g \in G$:

$$A \xrightarrow{\varphi} A'$$

$$\downarrow^{\lambda_g} \qquad \qquad \downarrow^{\lambda'_g}$$

$$g^*(A) \xrightarrow{g^*(\varphi)} g^*(A').$$

Thus, we have a category of linearized objects \mathcal{A}^G . The linearized category inherits properties of \mathcal{A} if \mathcal{A} is "rigid" enough, for example we have the following

Proposition 3.2. If G acts on an abelian category A by exact autoequivalences, then A^G is also an abelian category.

Proof. The existence of direct sums and the zero object is obvious. Given a G-invariant morphism $\varphi \colon (A, \lambda_g) \longrightarrow (A', \lambda'_g)$ the universal properties of the kernel and the cokernel in \mathcal{A} ensure that $\ker(\varphi)$ and $\operatorname{coker}(\varphi)$ are canonically linearized and the respective morphisms are G-invariant. Hence, kernels and cokernels exist. The most interesting part is the equality of the image and the coimage: by the above arguments these objects are linearized and it can be checked, using that the kernel is a monomorphism, that the isomorphism in \mathcal{A} between $\operatorname{im}(\varphi)$ and $\operatorname{coim}(\varphi)$ is G-invariant.

If G acts on a triangulated category \mathcal{T} by exact autoequivalences, then, given a G-invariant map φ , it is not clear how to linearize a cone of this map. Therefore we will take the detour via DG-categories.

There is the following easy result.

Proposition 3.3. If A is a DG-category with an action by a group G, then the category of linearized objects as defined above is a DG-category.

Proof. We only need to prove that the space of morphisms has the structure of a complex. This boils down to proving that for any morphism $\varphi \colon (A, \lambda_g) \longrightarrow (A', \lambda'_g)$ the morphism $d(\varphi) \colon A \longrightarrow A'$ is also compatible with the linearizations. Since λ_g is a DG-isomorphism for all $g \in G$ we, in particular, have that any λ_g is closed, that is, $d(\lambda_g) = 0$ for all $g \in G$. Now one only has to use the Leibniz rule, the fact that λ'_g has degree 0 and that any $g \in G$ defines a DG-functor and therefore is compatible with the differentials:

$$\lambda_g'\circ\varphi=g^*(\varphi)\circ\lambda_g\Longrightarrow\lambda_g'\circ d(\varphi)=d(\lambda_g'\circ\varphi)=d(g^*(\varphi)\circ\lambda_g)=g^*(d(\varphi))\circ\lambda_g.$$

Remark 3.4. Given an action of an algebraic group G on a variety X denote the action by $\sigma: G \times X \longrightarrow X$ and the multiplication by $\mu: G \times G \longrightarrow G$. One defines a linearization of a sheaf \mathcal{F} in this case to be an isomorphism $\lambda: \sigma^*\mathcal{F} \longrightarrow p_2^*\mathcal{F}$ of $\mathcal{O}_{G \times X}$ -modules subject to the cocycle condition $(\mu \times \mathrm{id}_X)^*\lambda = p_{23}^*\lambda \circ (\sigma \times \mathrm{id}_G)^*\lambda$, where $p_2: G \times X \longrightarrow X$ and $p_{23}: G \times G \times X \longrightarrow G \times X$ are the projections. For a finite (or discrete) group this reduces to isomorphisms $\mathcal{F} \longrightarrow g^*\mathcal{F}$ as above. Hence, we should not expect the above construction to be compatible with geometry in the case of an arbitrary group (there is a notion of an equivariant derived category in this case, see [1]).

Definition 3.5. We define the forgetful functor **Forg** as the functor $\mathcal{A}^G \longrightarrow \mathcal{A}$ which forgets the linearizations. The inflation functor **Inf** from \mathcal{A} to \mathcal{A}^G is the functor which on objects is defined by $A \longmapsto \bigoplus_g g^*(A)$.

Remark 3.6. Given a subgroup $H \subset G$, we have an obvious DG-functor $\mathcal{A}^G \longrightarrow \mathcal{A}^H$. This functor is clearly faithful, but the case $H = \{1\}$ shows that it is not essentially surjective in general.

Note that, since there always exists an extension of a DG functor on the pretriangulated hulls, the action of G on \mathcal{A} naturally extends to an action on $\mathcal{A}^{\text{pretr}}$. Explicitly, the action of G on the formal shifts is clear and for an object $(\bigoplus_{i=1}^n C_i[r_i], q)$ in $\mathcal{A}^{\text{pretr}}$ we simply apply an element g in G to the components of q. One then checks that the condition $d(q)+q^2=0$ induces that $d(g^*(q))+g^*(q)^2=0$ (to see this note that $g^*(\alpha\beta)=g^*(\alpha)g^*(\beta)$ and similarly for sums; hence g^* is compatible with matrix multiplication) and hence the action is well-defined. The definition of the action on morphisms is similarly straightforward.

Proposition 3.7. If G is a group acting on a strongly pretriangulated DG-category A, then A^G is also strongly pretriangulated.

Proof. Consider the formal shift of a linearized object $(A, \lambda_g)[1]$. We know that A[1] is DG-isomorphic to an object A' of A and λ_g induces a linearization λ'_g of A'. It is then clear that $(A, \lambda_g)[1]$ is DG-isomorphic to (A', λ'_g) . The reasoning for the cone of a closed degree zero morphism is similar.

Remark 3.8. We cannot show that the statement of the lemma holds true without the "strongly" assumption.

One would need to show that for every $k \in \mathbb{Z}$ and any $(A, \lambda_g) \in \mathcal{A}^G$ the object $(A, \lambda_g)[1]$ is homotopy equivalent to an object in \mathcal{A}^G and similarly that the cone of any closed degree zero morphism also has this property. Let $\varphi \colon (A, \lambda_g) \longrightarrow (A', \lambda'_g)$ be a closed degree zero morphism in \mathcal{A}^G . For simplicity write \widetilde{A} for (A, λ_g) and similarly $\widetilde{A'}$ for (A', λ'_g) . By definition the cone $C(\varphi)$ is the object $(\widetilde{A'}[1] \oplus \widetilde{A}, q)$, where q is the (2×2) -matrix with $q_{12} = \varphi$ and 0 otherwise. On the other hand, the cone of φ considered in $\mathcal{A}^{\operatorname{pretr}}$, which we will denote by $C'(\varphi)$, has a linearization γ_g given by

$$\begin{pmatrix} \lambda_g' & 0 \\ 0 & \lambda_g \end{pmatrix}$$

Using that \mathcal{A} is pretriangulated we know that $C'(\varphi)$ is homotopy equivalent to an object D of \mathcal{A} , but the linearization γ_g does not necessarily induce a linearization δ_g on D.

We can now give our definition of the linearized triangulated category.

Definition 3.9. Let \mathcal{T} be the homotopy category of a pretriangulated DG-category \mathcal{A} and let G be a group acting on \mathcal{A} and hence on \mathcal{T} . The *linearization* of \mathcal{T} by G, denoted by $\mathcal{T}_{\mathcal{A}}^{G}$, is defined to be $H^{0}((\mathcal{A}^{G})^{\operatorname{pretr}})$.

Since the enhancement will usually be clear from the context, we will simply write \mathcal{T}^G instead of \mathcal{T}^G_A .

Remark 3.10. Given an additive category \mathcal{T} and an automorphism Φ there is an "orbit category" \mathcal{T}/Φ , which has the same objects as \mathcal{T} and the morphisms between two objects A and B are given by

$$\bigoplus_{n\in\mathbb{Z}} \operatorname{Hom}_{\mathcal{T}}(A, \Phi^n B).$$

If \mathcal{T} is a triangulated category, then \mathcal{T}/Φ is not triangulated in general, but under some fairly strong assumptions it does have a triangulated structure, see [10]. In particular, the mentioned assumptions are not satisfied by $\mathrm{D}^b(X)$ for X a smooth projective variety. In general, the orbit category does not seem to capture quotients: Consider a smooth projective variety X with an action by an automorphism such that X/G is smooth and the category $\mathbf{Coh}(X)$, considered for simplicity as an additive category. Then the orbit category is $\pi_* \mathbf{Coh}(X)$ and not $\mathbf{Coh}(X/G)$.

Under certain assumptions the construction is functorial. Namely, assume that G acts on two pretriangulated DG-categories \mathcal{A} and \mathcal{A}' and that we are given an equivariant DG-functor $F: \mathcal{A} \longrightarrow \mathcal{A}'$ meaning that the following diagram commutes for all $g \in G$:

$$\begin{array}{c|c}
\mathcal{A} & \xrightarrow{\Phi} \mathcal{A}' \\
g^* \downarrow & & \downarrow g^* \\
\mathcal{A} & \xrightarrow{\Phi} \mathcal{A}'.
\end{array}$$

Then Φ induces a functor $\Phi^G : \mathcal{A}^G \longrightarrow (\mathcal{A}')^G$ by sending (A, λ_g) to $(\Phi(A), \Phi(\lambda_g))$ and similarly for maps. Using the induced functor on the pretriangulated hulls, we get an exact functor $H^0((\Phi^G)^{\operatorname{pretr}}) : \mathcal{T}^G \longrightarrow (\mathcal{T}')^G$.

As a particular example of this consider the situation of a triangulated subcategory. So, suppose we are given a triangulated category $\mathcal{T} = H^0(\mathcal{A})$ with a group action and a triangulated subcategory \mathcal{T}' such that the action of G restricts to an action on the natural enhancement of \mathcal{T}' (i.e., the objects of the enhancement are those objects A' in \mathcal{A} such that $H^0(A') \in \mathcal{T}'$). Then $(\mathcal{T}')^G$ is a triangulated subcategory of \mathcal{T}^G .

It is, of course, an interesting question whether the construction depends on the choice of the enhancement, that is, if \mathcal{T} can be written as the homotopy category of two distinct DG-categories \mathcal{A} and \mathcal{B} , is then $\mathcal{T}_{\mathcal{A}}^G$ equivalent to $\mathcal{T}_{\mathcal{B}}^G$. We will now see that this can be indeed shown, albeit under some assumptions.

Lemma 3.11. Let \mathcal{A} and \mathcal{B} be two pretriangulated DG-categories and let $\Phi \colon \mathcal{A} \longrightarrow \mathcal{B}$ be an equivariant quasi-equivalence. Assume that for all $(A, \lambda_g), (A', \lambda'_g) \in \mathcal{A}^G$ and for all $\varphi \in \operatorname{Hom}_{\mathcal{A}}(A, A')$ we have that $g^*(d\varphi)\lambda_g = \lambda'_g d\varphi$ implies that $g^*(\varphi)\lambda_g = \lambda'_g \varphi$ (we call this condition (*)) and similarly for \mathcal{B} . Then Φ^G is quasi fully faithful.

Proof. Condition (*) ensures that $H^i_{\mathcal{A}^G}((A,\lambda_g),(A',\lambda'_g))$ embeds into $H^i_{\mathcal{A}}(A,A')$ for all i. The commutativity of the following diagram (for all $i \in \mathbb{Z}$):

combined with the injectivity of the left vertical map and the fact that the lower map is an isomorphism implies the injectivity of $H^i(\Phi^G)$.

Next, take an element $\overline{\psi}$ in $H^i_{\mathcal{B}^G}((\Phi(A), \Phi(\lambda_g)), (\Phi(A'), \Phi(\lambda'_g)))$. Since by (*) the right vertical map is injective this gives an element in $H^i_{\mathcal{B}}(\Phi(A), \Phi(A'))$ and hence a unique element $\overline{\varphi}$ in $H^i_{\mathcal{A}}(A, A')$. We need to check that in fact $\overline{\varphi}$ is in $H^i_{\mathcal{A}^G}((A, \lambda_g), (A', \lambda'_g))$. By assumption and quasi-faithfulness of Φ we have that

$$g^*(\varphi)\lambda_q - \lambda_q'\varphi = d(\alpha_q)$$

for some α_g (here φ is a representative of $\overline{\varphi}$). Differentiating the above equation gives that $d(\varphi)$ commutes with the linearizations and therefore, by (*), φ does. Hence, Φ^G is quasi fully faithful.

Proposition 3.12. In addition to the assumptions of the previous lemma let furthermore $\Psi \colon \mathcal{B} \longrightarrow \mathcal{A}$ be an adjoint equivariant quasi-equivalence. Then $\mathcal{T}_{\mathcal{A}}^{G}$ and $\mathcal{T}_{\mathcal{B}}^{G}$ are equivalent.

Proof. Since Φ and Ψ are adjoint, so are Φ^G and Ψ^G . Both these functors are quasifully faithful and hence define equivalences on the homotopy categories. Now use that if a DG-functor F is a quasi-equivalence, then so is F^{pretr} .

Remark 3.13. One probably should not expect that our construction is independent of the choice of the enhancement in general, since linearizations do use the DG-structure. Of course, it may then be asked what the relation between \mathcal{T}_A^G and \mathcal{T}_B^G is.

It is difficult to produce new interesting autoequivalences of finite order in the geometric setting. The case of a finite group of automorphisms will be settled in the next section. The next case is the action of the group generated by a line bundle of finite order, which will be partially dealt with in Section 5. Basically, these are the only examples we have at our disposal. One might hope to produce new ones by conjugating the action of one of the above-mentioned groups but we will now see that this does not give anything new.

Let G act on a pretriangulated DG-category \mathcal{A} , let Φ be a DG-equivalence of \mathcal{A} , consider the action of G given by $g \mapsto \Phi^{-1} \circ g^* \circ \Phi$ and denote the DG-category linearized with respect to this action by $\mathcal{A}^{\tilde{G}}$. Then we have the

Proposition 3.14. The categories \mathcal{A}^G and $\mathcal{A}^{\widetilde{G}}$ are DG-equivalent.

Proof. The functor F sending an object (A, λ_g) in \mathcal{A}^G to $(\Phi^{-1}(A), \Phi^{-1}(\lambda_g))$ is easily seen to be a DG-equivalence.

4. The case of automorphisms

Of course, one has to check that the above procedure produces the derived category of [X/G] if G is a finite group of automorphisms of X. Denote the cardinality of G by n. There are canonical isomorphisms $(gh)^* \simeq h^*g^*$ and these will be used to define the action of G.

We first recall some useful facts. There is an equivalence $(\mathbf{Q})\mathbf{Coh}([X/G]) \simeq (\mathbf{Q})\mathbf{Coh}^G(X)$, where the latter is the category of linearized sheaves. The quotient morphism $\pi \colon X \longrightarrow [X/G]$ is flat, hence π^* is exact. Using the adjunction

$$\text{Hom}(\pi^*(-), -) \simeq \text{Hom}(-, \pi_*(-))$$

and the exactness of π^* we see that the pushforward of an injective sheaf on X is an injective sheaf on [X/G].

Now consider $\mathcal{T} = D^b(X)$ as the homotopy category of $D^b_{DG}(X) =: \mathcal{A}$. Then an object of \mathcal{A}^G is by definition a complex as above together with chain isomorphisms λ_g satisfying the linearization relation. Since \mathcal{A} is strongly pretriangulated, so is \mathcal{A}^G (see Proposition 3.7).

We need the following.

Lemma 4.1. Let $\mathcal{F}' = (\mathcal{F}, \lambda_g)$ be an injective sheaf on [X/G]. Then $\mathcal{F} = \pi^*(\mathcal{F}')$ is an injective sheaf on X.

Proof. Denote [X/G] by Y and the Serre functor by S_X resp. S_Y . The result follows from the following computation:

$$\operatorname{Hom}_{X}(-, \pi^{*}(\mathcal{F}')) \simeq \operatorname{Hom}_{X}(\pi^{*}(\mathcal{F}'), S_{X}(-))^{\vee} \simeq \operatorname{Hom}_{Y}(\mathcal{F}', \pi_{*}S_{X}(-))^{\vee} \simeq$$
$$\simeq \operatorname{Hom}_{Y}(\pi_{*}S_{X}(-), S_{Y}(\mathcal{F}')) \simeq \operatorname{Hom}_{Y}(S_{V}^{-1}\pi_{*}S_{X}(-), \mathcal{F}').$$

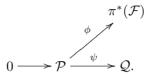
Note that the functor $S_Y^{-1}\pi_*S_X$ takes sheaves to sheaves, since the shifts cancel out. Furthermore, \mathcal{F}' is injective by assumption, π_* is exact and tensoring with line bundles is also exact, hence we conclude that $\operatorname{Hom}(-,\pi^*(\mathcal{F}'))$ is an exact functor and therefore $\mathcal{F}=\pi^*(\mathcal{F},\lambda_g)$ is injective.

Remark 4.2. Let us have a second look at the above proof. In our situation one has that $\pi^*\omega_Y \simeq \omega_X$ since $\omega_X \simeq \pi^*\omega_Y \otimes \mathcal{O}(R)$, where R is the ramification locus. Hence the projection formula gives that

$$S_Y^{-1}\pi_*S_X(\mathcal{F}) \simeq \pi_*(\mathcal{F} \otimes \omega_X) \otimes \omega_Y^{-1} \simeq \pi_*(\mathcal{F}).$$

The forgetful functor **Forg** corresponds to π^* and the inflation functor **Inf** corresponds to π_* . Hence, **Forg** \circ **Inf** $\simeq \bigoplus_{g \in G} g^* \simeq \pi^* \pi_*$.

Consider the following diagram in $\mathbf{QCoh}(X)$:



We need to construct a map $\theta: \mathcal{Q} \longrightarrow \pi^*(\mathcal{F})$ making the diagram commutative. Apply π_* to the diagram. Since $\pi_*\pi^*(\mathcal{F}) = \mathcal{F} \otimes \pi_*\mathcal{O}_X$ and $\pi_*\mathcal{O}_X = \mathcal{L}$ is locally free, $\pi_*\pi^*(\mathcal{F})$ is an injective sheaf again and therefore we get a diagram

Applying π^* and using that $\pi^*\pi_* = \bigoplus_q g^*$ we get

$$0 \longrightarrow \bigoplus_{g} g^{*}(\varphi) \xrightarrow{\left(\pi^{*}(\mathcal{F})\right) \oplus n} \\ \uparrow^{\pi^{*}(\alpha)} \\ \downarrow^{\pi^{*}(\alpha)} \\ \oplus_{g} g^{*}(\psi) \xrightarrow{\bigoplus_{g} g^{*}(\psi)} \oplus_{g} g^{*}(\mathcal{Q}).$$

Denoting the inclusion of \mathcal{Q} in $\bigoplus_g g^*(\mathcal{Q})$ by ι and the first projection from $(\pi^*(\mathcal{F}))^{\oplus n}$ to $\pi^*(\mathcal{F})$ by p_1 , the wanted morphism θ is then $p_1 \circ \pi^*(\alpha) \circ \iota$.

Let $\mathcal{D}^b_{\mathrm{DG}}([X/G])$ be the enhancement of $\mathcal{D}^b([X/G])$ by injective sheaves. Using the above lemma we can construct a functor from $\mathcal{D}^b_{\mathrm{DG}}([X/G])$ to \mathcal{A}^G : If a complex of injective linearized sheaves $(\mathcal{F}^i,\lambda_g^i)$ is given, then we can send it to the complex having the \mathcal{F}^i as terms and the linearization of this complex is given termwise by the λ_g^i . A map in \mathcal{B} is simply sent to itself. Clearly, this is fully faithful, so in particular we get:

Proposition 4.3. There exists a DG-equivalence $\Phi \colon \mathrm{D}^b_{\mathrm{DG}}([X/G]) \longrightarrow \mathcal{A}^G$. Hence, $\mathrm{D}^b(X)^G \simeq \mathrm{D}^b[X/G]$.

The previous discussion can be used to deduce the following

Corollary 4.4. Let Y be a Fourier–Mukai partner of X, let G be a finite group of automorphisms acting on Y and fix an equivalence $F: D^b(X) \xrightarrow{\sim} D^b(Y)$. If we let the group G acts on $D^b(X)$ by $F^{-1} \circ g^* \circ F$ for any $g \in G$, then $D^b(X)^G$ is equivalent to $D^b([Y/G])$.

Proof. If we write $D^b(X)$ as the homotopy category of $D^b_{DG}(Y)$, the result follows immediately.

Example 4.5. Let us now consider the following situation. Let G act on X without fixed points and consider the quotient map $\pi \colon X \longrightarrow X/G =: Y$. Take the structure sheaf \mathcal{O}_Z of a subvariety $Z \subset Y$ and consider the full triangulated subcategory \mathcal{T} generated by \mathcal{O}_Z in $D^b(Y)$. Pulling \mathcal{O}_Z up to X gives the direct sum of \mathcal{O}_{Z_i} , where $\cup Z_i$ is the preimage of Z (for example, Z could be a rational curve on an Enriques surface and then we get two rational curves Z_1 and Z_2 on the covering K3 surface). Consider the triangulated subcategory of $D^b(X)$ generated by the sheaves \mathcal{O}_{Z_i} and denote it by \mathcal{T}' . Then we have an equivalence $(\mathcal{T}')^G \simeq \mathcal{T}$.

Indeed, $\bigoplus_i \mathcal{O}_{Z_i}$ can be linearized, hence $\mathcal{O}_Z \in (\mathcal{T}')^G$ and therefore $\mathcal{T} \subset (\mathcal{T}')^G$. On the other hand, \mathcal{T}' is built from the \mathcal{O}_{Z_i} by taking iterated extensions and shifts, whose support is always contained in the union of the \mathcal{O}_{Z_i} . Therefore the only objects that can be linearized are generated by $\bigoplus_i \mathcal{O}_{Z_i}$ and therefore the other inclusion holds as well.

5. Applications

5.1. Linearisations with respect to a torsion canonical bundle. Having studied the above, we will look at the case of a linearization with respect to a line bundle twist. Recall (Proposition 3.2) that given an action of a finite group G on an abelian category, the category of linearized objects is also abelian. We will now consider the following situation. Let S be a variety whose canonical bundle is of finite order, fix an isomorphism $f: \omega_S^n \simeq \mathcal{O}_S$ and consider the global spectrum \widetilde{S} of the corresponding sheaf of \mathcal{O}_S -algebras. Using f, the sheaf $\mathcal{O}_S \oplus \omega_S \oplus \cdots \omega_S^{n-1}$ becomes an \mathcal{O}_S -algebra and \widetilde{S} has a fixed point-free automorphism τ of order n corresponding to the action of ω_S . Denote the quotient morphism $\widetilde{S} \longrightarrow S$ by π . The isomorphism f induces an action of $\mathbb{Z}/n\mathbb{Z}$ on the category of (quasi-)coherent sheaves on S by sending 1 to the functor $(-) \otimes \omega_S$. We can consider sheaves linearized with respect to this action. Any such sheaf \mathcal{F} has, in particular, the property that $\mathcal{F} \simeq \mathcal{F} \otimes \omega_S$. This holds, for example, for $\mathcal{F} = \bigoplus_{k=0}^{n-1} \omega_S^k$.

Now recall that by [8, Example II.5.17] there exists an equivalence between $(\mathbf{Q})\mathbf{Coh}(\widetilde{S})$ and the category of (quasi-)coherent $\pi_*\mathcal{O}_{\widetilde{S}}$ -modules. Note that the pullback of f is the identity morphism of $\mathcal{O}_{\widetilde{S}}$ and that the canonical isomorphism $\pi_*\mathcal{O}_{\widetilde{S}} \simeq \bigoplus_{k=0}^{n-1} \omega_S^k$ is an isomorphism of \mathcal{O}_S -algebras.

Lemma 5.1. Let $\widetilde{\mathcal{F}}$ be a (quasi-)coherent sheaf on \widetilde{S} . Then $\pi_*(\widetilde{\mathcal{F}})$ is linearized with respect to the above described action of $\mathbb{Z}/n\mathbb{Z}$ on the category of (quasi-)coherent sheaves on S.

Proof. We use the projection formula to get an isomorphism

$$\alpha \colon \pi_*(\widetilde{\mathcal{F}}) \simeq \pi_*(\widetilde{\mathcal{F}} \otimes \mathcal{O}_{\widetilde{S}}) \simeq \pi_*(\widetilde{\mathcal{F}} \otimes \pi^*(\omega_S)) \simeq \pi_*(\widetilde{\mathcal{F}}) \otimes \omega_S.$$

Since the isomorphism in this formula is canonical, the morphism $(\alpha \otimes id) \circ \alpha$, resp. further compositions are also canonical. On the other hand, composing the n-fold composition with f gives the identity because f enters in the very definition of \widetilde{S} and hence of π . Alternatively, and briefly assuming n=2 to simplify notation, one can use that π^* is a faithful functor and the fact that the pullback of $f \circ (\alpha \otimes id) \circ \alpha$ is the identity map of $\pi^*\pi_*\widetilde{\mathcal{F}} \simeq \widetilde{\mathcal{F}} \oplus \tau^*(\widetilde{\mathcal{F}})$.

Now, given a linearized sheaf (\mathcal{F}, α) we can define a structure of $\pi_* \mathcal{O}_{\widetilde{S}}$ -module on it by locally setting

$$(s,t)\cdot\gamma:=s\cdot\gamma+\alpha(t\otimes\gamma),$$

for sections of \mathcal{O}_S , ω_S and \mathcal{F} respectively. Clearly, these two constructions are inverse to each other and $\pi_*\mathcal{O}_{\widetilde{S}}$ -linearity translates to invariance with respect to the group action. Hence, we have

Proposition 5.2. There is an equivalence $(\mathbf{Q})\mathbf{Coh}(\widetilde{S})$ and $(\mathbf{Q})\mathbf{Coh}^{\mathbb{Z}/n\mathbb{Z}}(S)$.

Corollary 5.3. There exists an equivalence $D^b(S)^{\mathbb{Z}/n\mathbb{Z}} \simeq D^b(\widetilde{S})$.

Proof. This follows from the proposition, the fact that $\pi_*(\mathcal{F})$ of an injective sheaf \mathcal{F} is an injective $\pi_*\mathcal{O}_{\widetilde{S}}$ -module and with similar arguments as in Section 4.

5.2. The category generated by a spherical object. Let X be a smooth projective variety of dimension d. Recall that an object E in $D^b(X)$ is d-spherical if $E \otimes \omega_X \simeq E$ and if $\operatorname{Hom}(E, E) = \operatorname{Hom}(E, E[d]) = \mathbb{C}$ and 0 otherwise. More generally, one can define a d-spherical object in a triangulated category \mathcal{T} to be an object E with the property that the graded endomorphism algebra

$$B = \bigoplus_{p \in \mathbb{Z}} \operatorname{Hom}_{\mathcal{T}}(E, E[p])$$

is isomorphic to $\mathbb{C}[s]/(s^2)$ and s is of degree d.

For example, any line bundle on a Calabi–Yau variety of dimension d (that is, $\omega_X \simeq \mathcal{O}_X$ and $H^i(X, \mathcal{O}_X) = 0$ for $i \neq 1, d$) is a d-spherical object. The interest in these objects stems, in particular, from the fact that one can associate an autoequivalence of $D^b(X)$ to any spherical object, the so-called *spherical twist* (see [15]).

Recall that an object E in $D^b(X)$ is called *exceptional* if $Hom(E, E) = \mathbb{C}$ and Hom(E, E[k]) = 0 for all $k \neq 0$. Note that spherical objects are usually studied on Calabi–Yau varieties while the most natural environment for exceptional objects are probably Fano varieties. Nevertheless, there is a connection between spherical objects and exceptional objects, see, for example [15, Subsection 3.3].

In [11, Theorem 2.1] the authors determined the structure of the triangulated category generated by a d-spherical object (d is arbitrary). Denoting this category by \mathcal{T}_d , there exists an equivalence between \mathcal{T}_d and the perfect derived category $\operatorname{Perf}(B)$ of the algebra B introduced above (with B corresponding to the spherical object), which is considered as a DG-algebra with trivial differential. Recall that $\operatorname{Perf}(B)$ is the smallest thick triangulated subcategory of the derived category of B which contains B. Since B is a local ring, $\operatorname{Perf}(B)$ is just the homotopy category of bounded complexes of finitely generated free B-modules. The enhancement one uses here is the DG-category associated to the additive category of finitely generated free B-modules.

In [7, Lemma 2.3] the group of autoequivalences of \mathcal{T}_d which admit DG-lifts was determined. Namely, it is isomorphic to $\mathbb{C}^* \times \mathbb{Z}$, where \mathbb{Z} corresponds to the action of powers of the shift functor and an element a in \mathbb{C}^* acts by the functor induced by the ring isomorphism $\varphi_a \colon B \longrightarrow B$, $s \longmapsto a \cdot s$. Note that for any $n \in \mathbb{Z}$ we have that $G = \mathbb{Z}/n\mathbb{Z}$ acts on \mathcal{T}_d by identifying G with the group of nth roots of unity (clearly, the group action is well-defined).

Let us first spell out what a linearization in a special case is, namely for n = 2 and the B-module B itself. Note that we are therefore working in the category of modules.

Acting by the non-trivial group element means changing the module structure of B as a B-module: The element s acts on an element of B not by multiplication with s itself, but with -s. Let $\lambda_g \colon B \longrightarrow (-1)^*B$ send 1 to $\alpha + \beta s$. In order for λ_g to be B-linear, we then must have $\lambda_g(s) = -\alpha s$. Furthermore, if we want λ_g to be linearization, it has to be of order 2, so we conclude that $\alpha^2 = 1$ (and β is arbitrary). Thus, for any $\beta \in \mathbb{C}$ we get linearizations $\lambda_g^{1,\beta}$ ($1 \longmapsto 1 + \beta s$) and $\lambda_g^{-1,\beta}$ ($1 \longmapsto -1 + \beta s$) of B. However, there is the following

Lemma 5.4. The linearized objects $(B, \lambda_g^{1,\beta})$ and $(B, \lambda_g^{1,\beta'})$ are isomorphic for $\beta \neq \beta'$. A similar statement holds for $\lambda_g^{-1,\bullet}$.

Proof. A *B*-linear automorphism of *B* is a map sending 1 to x + ys and s to xs for $x \neq 0$. Denote $\beta' - \beta$ by z. The map f will commute with the linearizations if we choose x, y such that $z = \frac{2y}{x}$.

So, we can work with $\beta = 0$. Denote $\lambda_q^{\pm 1,0}$ by $\lambda_q^{\pm 1}$.

Lemma 5.5. The objects (B, λ_g^1) and (B, λ_g^{-1}) are not isomorphic. The endomorphism ring of (B, λ_g^1) resp. of (B, λ_g^{-1}) is isomorphic to \mathbb{C} .

Proof. If $f: B \longrightarrow B$, $1 \longmapsto x + ys$ is a map commuting with the linearizations, then we have

$$x + ys = f\lambda_q^1(1) = \lambda_q^{-1}f(1) = \lambda_q^{-1}(x + ys) = -x + ys,$$

hence x = 0 and f cannot be an isomorphism.

Concerning the second statement we only deal with the first case. Given an f as before we have

$$x + ys = f\lambda_a^1(1) = \lambda_a^1 f(1) = x - ys,$$

hence y=0 and the endomorphisms of (B,λ_g^1) (resp. of (B,λ_g^{-1})) are therefore the morphisms f sending 1 to $x\in\mathbb{C}$.

Combining everything we have

Proposition 5.6. Let \mathcal{T}_d be the triangulated category generated by a d-spherical object E and consider the action of $G = \mathbb{Z}/2\mathbb{Z}$ on it defined above. Then E admits two distinct linearizations λ_g^1 and λ_g^{-1} and the objects (E, λ_g^1) and (E, λ_g^{-1}) are exceptional in the linearized category. In particular, the linearized category \mathcal{T}_d^G contains the derived category of \mathbb{C} -vector spaces as a full admissible (the admissibility follows from [2, Theorem 3.2]) triangulated subcategory.

Note that the exceptional objects $E_1 = (E, \lambda_g^1)$ and $E_2 = (E, \lambda_g^{-1})$ are not orthogonal. For larger n the situation becomes more complicated.
